


Breeding Analysis

High Street was purchased by Regal Racers & Bloodstock in foal to Peltzer. The breeding cross was exciting for the "old school" close relationship with High Chaparral on both sides.

The breeding pattern demonstrated six graded stakes winners with CSI values of 18. This indicates that the breeding cross is very good as there are at least six superior horses with a very similar pattern.





Aptitude Profile - Distance

The aptitude profile for similar breeding demonstrates the possibility of racing 1400-2400 as an open horse and the possibility of 2000 as a 3 year old.

The dams lineage suggests that when you have a good distance horse it is very good, for example TITLEHOLDER, 7 wins from 1800-3200 Gr1 & Gr2.
